

# ARTS DISTRICT LOS ANGELES BID MINUTES

#### I. Call to Order

Bhavnani called the August BID meeting to order at 2:21 pm. Director Vargas took roll call.

He reviewed the cash flow for ADLA and then asked if there were any questions. Rosenfeld commented that the financials looked excellent. He commended Vargas for his cost restraint. Vargas thanked Rosenfeld for the kind words. Bhavnani reminded the Board that the minutes could not be approved so he moved on.

#### V. Operations Report

Reggie from Chrysalis went over the August maintenance statistics with the Board. He spoke about the amount of trash our maintenance team picked up in August and also shared a few pictures with the Board that captured the day-to-day work the BID does to keep the Arts District clean. Afterwards Captain Avina gave the safety report for the month. Avina highlighted how BTFV's still continuing to be a nuisance crime for the area but pointed out that BTFV's for the last three months have remained stable. Vargas noted that the crime statistics presented in the report was incomplete and missing the last 5 days of the month. Vargas said he was not able to complete the report because crime stats for the last month were not in a digestible format.

Vargas had nothing to announced.

#### VII. New Business

Bhavnani asked if there was any new business. Vargas explained that the proposal to provide services to the Gallery Lofts still needed approval but that it would have to wait until next month. Bhavnani thanked Vargas.
