- I. **Call to Order**  
Chairman Wulf called the March ADLA Board Meeting to order at 1:33 pm. Director Vargas took roll call.
- II. **Public Comments**

- III. **Approval of ADLA Board Meeting Minutes**  
Chairman Wulf asked for a motion to approve the March Board of Directors meeting minutes. Board Member Dilip Bhavnani motioned to approve the minutes. Board Member Lauren Phillips seconded the motion. The March meeting minutes were approved. Wulf moved to the next item on the agenda.
- IV. **Public Safety Report**

Alex Schaffer and Sandip Soni of LADOT gave an update on the upcoming installation of parking meter across the neighborhood. They informed the Board that most of the parking meters will be installed on 3<sup>rd</sup> Street, Traction Avenue, Santa Fe Avenue, Vignes Street, and Gary Street. Additionally, Schaffer stated that a parking app is in the works. Several Board Members asked about the possibility of converting some of the parking spots into electric vehicle charging stations. Soni explained that public EV charging is overseen by LADWP but both departments would have to cooperate. Seeing that there were no more questions, Chairman Wulf moved to the next item on the agenda.
- VI. **Artist Report**  
Board Member Adam Normandin gave the artist report. He explained that the artist committee was still working with Leah Smithson to find a location for her mural. Wulf thanked Adam for the artist update and moved on.
- VII. **LARABA Update**  
There were no new updates from LARABA. Chairman Wulf moved to the next item on the agenda.
- VIII. **New Business**  
Vargas informed the Board that the ATP recently broke ground. Vargas elaborated on the project, stating that it will add bike lanes, cross walks, and new street lights

to the neighborhood. A few Board members had a few questions. Wulf thanked Vargas and moved on.
