- I. **Call to Order**  
Vice Chairman Beth Stryker called the meeting to order at 1:36 p.m.

- IV. **Approval of ADLA Board Meeting Minutes**  
Stryker called for approval of the minutes. Normandin motioned to approve the minutes, which were seconded by Klein. The minutes were approved unanimously.
- V. **Public Safety Report**  
Stryker asked for the Public Safety Report. Seeing that no police officer was present, she moved on.
- VI. **Artist Report**  
Stryker asked for the Artist Report. Normandin reported that a few irons were in the fire but that he had nothing concrete to report until the next meeting. Stryker then announced that Artshare is seeking a wall to paint a mural of Isabel Rojas on. She asked that any property owner interested in having a mural please contact her.
- VII. **LARABA Update**

- VIII. **New Business**
